- (5) 17.50% annualized rate on the total negative balance per business days, including, but not limited to, any NSF (Non-Sufficient Funds) and UNC (Uncollected Funds) fees incurred. We will assess the overdraft interest charge per statement cycle.
- (6) Initial Account Processing Fee applies to foreign individuals and foreign entities.
- (7) For Money Market and Savings Accounts, transactions are limited to six (6) transfers or withdrawals (or combination of 6 transfers and withdrawals) per each statement cycle to another of your account(s), or to third parties when these transfers are made-by means of preauthorized, automatic transfer, or telephone/electronic transfer, or by check, draft, debit card, or similar order.
- (8) International Finance Bank reimburses up to five ATM fees at the end of each statement cycle. The ATM fee reimbursement is for every ATM worldwide. International Finance Bank will not reimburse any currency exchange fee you might incur at any ATM.
